Ordinance No. 019-26: Introduced by: Mastroianni: An Ordinance to amend Part Eleven – Planning and Zoning Code of the Alliance Codified Ordinances by amending Section 1122.03.

Ordinance No. 020-26: Introduced by: Lohnes: An Ordinance making appropriations and transfers of funds in the 2026 appropriations to provide for necessary expenses and adjustments; and declaring an emergency.

Ordinance No. 021-26: Introduced by: Council as a Whole: An Ordinance ratifying a contract between the City of Alliance and the Alliance Administrative & Finance Employee Association (AAFEA); and declaring an emergency.

Ordinance No. 025-26: Introduced by: Cherry: An Ordinance authorizing and directing the Mayor of the City of Alliance, Ohio to purchase land from the Alliance City School District known as Alliance City lots 4602, 4603, 4604, 4605, 4606 and 4607. Part of outlot 25 (.79acres), and vacated alley, for the sum of \$10 upon completion of due diligence by the City Law Director, and the City Law Director's satisfaction of the results of said due diligence, and upon completion of transfer to the City to re-convey the property to the Greater Alliance Development Corporation (GADC) for reutilization; and declaring an emergency.

Ordinance No. 026-26: Introduced by: Council as a Whole: An Ordinance ratifying a contract between the City of Alliance and the Federation of United Employees; and declaring an emergency.

Ordinance No. 027-26: Introduced by: Edwards: An Ordinance amending the Sanitary Sewer Service charges by the Wastewater Treatment Plant for the treatment of septage and leachate.
