Regular meeting.

Minutes of previous meeting read and approved. Wm B. Crubaugh was sworn in as Councilman; filling vacancy caused by the decease of Bro. Jas. A. Brush. The site walk committee made a report as to side-walks, and the clerk reported that notices had been issued to persons reported by said committee.
