Alliance Ohio Jan 5 1880

Council convened in regular session

Mayor Day presiding Roll called Present Probst Webb Coates Transue Gray absent Morgan Minutes of last meeting read and approved.

A communication from E A Griffith concerning a crossing recently put down in front of her property on Avenue Street was read on motion of Gray seconded by Transue referred to side walk committee.

Petition of Citizens asking for a lamp post on Patterson Street near the C & P RR Crossing on motion of Gray seconded by Webb referred to gas Committee.

Petition of Citizens asking that a lamp post be located at Street bridge on Avenue Street was read on motion of Coates seconded by Probst was referred to Gas Committee.

Report of P. B. Garlands for Materials used on side walk and crossing during the month of Dec was read on motion accepted and ordered filed.

Report of Mayor Day for fines and licenses during the month of Dec amounting to \$5.75 was read on motion of Gray seconded by Transue accepted and ordered filed.
