

Council Record

Alliance Ohio Aug. 15, 1881

Council convened in regular session. Mayor Johnson presiding Roll called pursuant to ordinance. Beardsley Beardsley Coates Mercer absent Travers

Minutes read and corrected.

Petition of citizens on North Liberty Street for a well or cistern to be located near J. H. Beverington's, for the protection of property against fire. ^{was read} Motion of Coates seconded by Townsend. Petition was referred to fire Committee.

Petition of Citizens on Linden Avenue for two street lamps one on the South West corner at the crossing of said Avenue and Summit St and the other at the North East corner of Linden Ave and Grant Street.

Motion of Beardsley seconded by Mercer. Petition was referred to gas Committee.

The following Resolution was offered by Mr. Coates. Be it resolved by the Council of the Incorporated Village of Alliance Ohio that the owner of property herein described in the village of Alliance Ohio be and is now hereby required and ordered, within sixty days after due notice of the passage of this Resolution, to construct a sidewalk 66 ft in length on the west side of Mt Union Street fronting said property upon the elevation fixed by the ordinance now in force providing and establishing a grade on Mt Union Street in said village. That said sidewalk shall be six ft wide and constructed of stone or brick said property is described as follows to wit, That property belonging to C. W. Johnson Jr situated on the west side of Mt Union St and bounded on the north by land owned by Hugh Anderson and on the south and east by lands owned by Amos Coates. The Resolution

seconded by Stillwell and carried by the following vote year Townsend Stillwell Beardsley Coates Mercer year 5- nays 0. The Mayor declared the Resolution duly passed.

The following Resolution was offered and adopted. Be it resolved by the Council of the Incorporated Village of Alliance Ohio That the owner of Lot No. 84 in Docters. Lamborn & Co. addition to the village of Alliance Ohio be and is now hereby required and ordered, within sixty days after due notice to him of the passage of this Resolution to repair sidewalk in front of Lot No. 84 in ^{the} addition aforesaid upon the elevation fixed by the ordinance now in force providing and establishing a grade Liberty Street in said village. That said sidewalk shall be repaired by relaying the same and furnishing new stringers and planks in place of those so worn as to be dangerous or worthless for the use of a walk. The year and nays being called resulted as follows year Townsend Stillwell Beardsley Coates Mercer year 5- nays 0. The Mayor declared the Resolution duly passed.

Mr. Mercer offered the following resolution. Be it Resolved by the Council of the Incorporated Village of Alliance Ohio that the owner of Lot No. 6 in J. B. Wilness 1st addition to the Village of Alliance Ohio be and is now hereby required and ordered within sixty days after ^{due notice of} the passage of this resolution to construct a sidewalk on the east side of lot no. 6 in the addition aforesaid upon the elevation fixed by the ordinance now in force providing and establishing a grade on Park street in said village. That said sidewalk shall be 6ft wide and constructed of stone or brick seconded by Townsend and carried by the following vote. year Townsend Stillwell Beardsley Coates Mercer year 5- nays 0. The Mayor declared the Resolution duly passed.

The following Resolution was offered by Mr Townsend. Be it resolved by the Council of the Incorporated Village of Alliance Ohio that the owner of Lot no 15 in Hain's addition to the village of Alliance Ohio be and is now hereby required and ordered within sixty days after due notice to him of the passage of this Resolution to construct a sidewalk in front of Lot no 15 in the addition aforesaid, upon the elevation fixed by the ordinance now in force providing and establishing a grade on Alliance Street in said village. That said sidewalk shall be six ft wide and constructed of stone or brick. Seconded by Mercer and carried by the following vote, yeas Townsend Stillwell Beardsley Coates Mercer yeas 5 nays 0. The Mayor declared the Resolution passed.

The following resolution was offered. Stillwell and seconded by Beardsley. Be it resolved by the Council of the Incorporated Village of Alliance Ohio that the owner of South half of Lot no 100 in Peck's addition to the village of Alliance Ohio be and is now hereby required and ordered within sixty days after due notice to him of the passage of this Resolution, to construct a sidewalk on side of said $\frac{1}{2}$ lot fronting on Fifth Street in the addition aforesaid upon the elevation fixed by the ordinance now in force providing and establishing a grade on Fifth Street in said village. That said sidewalk shall be constructed of either stone or brick.

The yeas and nays being called on the above Resolution, resulted as follows. Townsend Stillwell Beardsley Coates Mercer yeas 5 nays 0. The Mayor declared the Resolution duly passed.

The following Resolution was offered by Mr. Mercer
 Be it Resolved by the Council of the Incorporated
 Village of Alliance Ohio that the owner of Lot No
 54 in Jennings & Brooks addition to the Village of
 Alliance Ohio be and is now hereby required and
 ordered within sixty days after due notice to him of
 the passage of this Resolution to construct a side-
 walk in front of Lot 54 in the addition aforesaid
 upon the elevation fixed by the ordinance now in
 force providing and establishing a grade on Station
 Street in said Village That said sidewalk shall
 be six ft wide and constructed of stone or brick.

The Resolution was seconded by Boardley and
 carried by the following vote Yeas Downward
 Sillwell Boardley Coates Mercer yeas 5 nays 0.

The Mayor declared the resolution duly passed.

The following Resolution was
 offered and adopted Be it resolved by the

 yeas 5 nays 0 The Mayor declared the Resolution duly
 passed.

 62 & 62 in Wilburns 2nd Addition to the Village of
 Alliance Ohio be and is now hereby required and

ordered within sixty days after due notice to her of the passage of this Resolution to construct a sidewalk in front of Lot No 61 & 63, in the addition aforesaid upon the elevation fixed by the ordinance now in force providing and establishing a grade on Mt Union Street in said. That said sidewalk shall be six feet wide and constructed of stone.

The yeas and nays being called resulted as follows: yeas Townsend Stillwell Beardsley Coates Mercer yeas 5 nays 0. The Mayor declared the Resolution duly passed.

The following Resolution was offered by Mr Townsend. That said side walk shall be six ft wide and constructed of bricks or stone.
