Resolution

Whereas in the death of General Grant. The nation has been called upon to Mourn the loss of one of its most distinguished Citizens whose invaluable service to his Country and whose unceasing devotion to the Union have done so much for the Comon

welfare of Mankind. A
 Whereas: It is fitting that we show
 Our respect for the Memory of the
 honored dead; that we manifest our
 appreciation and gratitude for the
 Service he rendered during the
 Years of our Nations severest trial
 And hold up his virtues for the im-
 mulation of our generation and of posterity.
 Be it resolved therefore; That, as Saturday
 August the 8th has been appointed
 for the funeral of General Grant. We
 the Council of the Incorporated Vil-
 lage of Alliance Ohio instruct the
 Mayor of the Village to issue a Procla-
 mation, requesting that on the Afternoon
 of the day of the funeral all places
 of business be Closed. And that the
 Citizens of the town and vicinity
 be requested to meet and take part
 in such Memorial Services as shall
 be appropriate for the Occasion.
 Resolved that a Committee be appointed
 by the Mayor to see that suitable
 Emblems of Mourning be displayed
 in the City building on the day
 of the funeral and that the Council
 Chamber be draped for a
 period of thirty days.

Resolved further That the City Clerk
 be instructed to copy these resolutions
