Inscott Moved that the Finance Committee
 be instructed to obtain two Mills additional
 to the Tax Levy providing the same come
 taken from the School Levy, and not increase
 the general amount of Taxation
 2ndly Keplinger & Carried

An Ordinance
 To Authorize the Alliance Gas Company
 its Successors or Assigns to Erect and Maintain
 Poles in the Streets, Avenues, Alleys and
 Public Squares Grounds in the Village of
 Alliance for certain purposes and under
 the Conditions herein stated.

Passed first reading - Inscott Moved that
 the rules be suspended to permit the Ordinance
 to Pass 2nd & 3rd reading and final Passage
 2ndly Myres, & Carried by the following
 vote Yeas Galbraith, Inscott, Myres, Keplinger
 Nays Earley. Yeas 4 Nays One. A vote
 was then taken on final Passage which
 stood as before Yeas 4 Nays One.
 The Chairman declared the Ordinance duly
 passed

On Motion the Clerk was instructed
 to Procure Poll Books for the coming Election
 Yeas 5 Nays None

The Chair appointed Earley, Keplinger & Myres
 to act as judges at the coming Election, on
 the North Precinct, & Herr, Galbraith &
 Inscott on the South

On Motion the Clerk was authorized
 to Procure Clerks for Election
