Resolution offered by Mr Johnson

Resolved that the Clerk be instructed to notify the Superintendent of the Alliance Water Works Co of the passage of an Ordinance authorizing the Extension of the Water Mains from Mt Union Street East Along Market Street to the intersection of Market with Park Street and thence South Along Park Street to the intersection of Park Street with Broadway and the Location of two fire Pumps on said Extension of Main. Also of the Passage of

an Ordinance Authorizing the Extension of Water Mains on Freedom Street South of with the Location of ~~the~~ two fire plugs One at the Corner of Oxford & Freedom Street and One at the Corner of Summit and Freedom Streets and that said Company be instructed to put down said Extensions without delay. On Motion of Johnson Seconded by Betts the Resolution was adopted.

### Petitions.

A petition was Presented and read from the Owners of more than  $\frac{2}{3}$  of the feet frontage of the Property abutting on Arch Street from Main Street to Rosebury Street. Asking for the Paving and grading of said Street with Fire Bricks Blocks for distance of at least 85 feet in width.
