

Council Chamber May 16<sup>th</sup> 1888

Council met Pursuant to Adjournment.

President Pennock Presiding

Members Present Pennock, Betts, Bush, Jones, Johnson,

On Motion of Mr Betts, seconded by Jones the Solicitor was instructed to prepare an Ordinance for the extension of Water Main from Park Street west along Park Street to Mt Union Street and from Oxford Street South on Liberty to Summit Street and the location of water Hydrants, in accordance with the report of the Water Committee.

Passed First Reading An Ordinance fixing the rate of Taxation in the City of Alliance and providing for the distribution of the Same for the year 1888.

Johnson Moved to suspend the rules requiring ordinances to be read on three different days and that the Ordinance be read the second time seconded by Williams and Carried Yeas Pennock, Betts, Bush, Miller, Jones, Johnson, Williams, Vick, Yeas 8 Nays none. The Ordinance was read the second time.

Betts Moved the rules be suspended that the Ordinance be read the third time + put on its final Passage. 2<sup>nd</sup> by Vick + Carried Yeas Pennock, Betts, Bush, Jones, Johnson, Miller, Williams, Vick, Yeas 8 Nays none. The Ordinance was read the 3<sup>rd</sup> time and the vote on its final Passage stood as before yeas 8 Nays none.

The President declared the Ordinance duly passed.

Treasurer Deel Reported that he had received \$57<sup>00</sup> from the Mayor which had been collected for fines + Licence Johnson Moved the

Same be Apportioned to the Police & Salary for  
Carriers.

Johnson Moved that the Treasurer be instructed  
to Apply the Amount of the West Main Street  
Improvement funds in his hands, to the Payment  
of on the bonded debt in said fund. Second by  
Betts and Carried.

On Motion the Clerk was requested to make  
out a Statement of the Amount of Outstanding  
Orders.

Mayor Chapman Reported that two  
Vacancies had Occured in the Board of Health  
by reason of the resignation of John McCounell  
and the Joseph McCounell Elect declining to serve.  
Councilman Miller Moved that Walter Webb  
be appointed to serve on the Board of Health  
to fill the vacancy of John McCounell resigned  
2<sup>nd</sup> by Johnson & Carried

Williams Moved that Jacob Hartzell be appoin-  
ted as a member of the Board of Health to serve  
for the term of two years. Second by Vick  
And Carried

Betts Moved that an Order be Authorized drawn  
on the Treasurer for \$1000. in favor of Mrs  
Margaret Russell being the full amount of  
her claim for damages against the Village  
of Alliance. Second by Johnson & Carried

Miller Vick Williams, Yeas 8 Nays None

Walk across the run on Park Street South
