sec 1 Be it Ordained by the Town Council of the Incorporated
Village of Alliance, that there shall be created
of solicitor for said incorporation.

sec 2 Said solicitor shall be appointed by the Council
annually at the first Meeting of the Council

Resolved To authorize the Towne & Corp
An ordinance or act relating to Public Auctions
of Public Auction in the Incorporation of Alliance

sec 1 Be it ordained by the Council of the Incorporated
Village of Alliance,

That it shall be unlawful for any person or persons
to sell by way of Public auction, outcry or
either directly or indirectly, within the corporate
limits of said Village of Alliance, any goods
or effects whatsoever, except utensils of husbandry
household furniture, real estate, produce, horses,
mules, sheep, hogs or neat cattle, or any property
of the State, County, Township or Village, or
any property or effects, directed by law to be sold
or permanent residents of said Village, and
first obtaining a licence therefor from the Mayor
or in his absence the Recorder, Clerk

sec 2 That said Mayor, or in his absence the Recorder,
shall on application issue a licence to any
person or persons to sell any goods or
disse that are not herein before excepted,
charge therefor a sum not less than fifty cents
nor more than ²⁰ ~~Five~~ dollars, for each day
part of a day.

sec 3 That if any person shall violate any of the
visions of this ordinance, by selling any goods
not herein excepted, at public auction, outcry
or outcry, shall forfeit and pay a sum
not more than
