

An Ordinance to Prohibit the Exp...

 Sec 1 Be it Ordained by the Town Council of the Village of Alliance, That it shall be unlawful for any person to sell, or give away, any Fire Crackers discharged in any of the streets, or public squares or alleys, within the incorporated limits of said Village. Any person ^{so} offending shall upon Conviction before the Mayor, or other proper Officers, and pay a fine Not Exceeding Ten Dollars, less than one dollar, with costs of prosecution.

Fire Crackers
 Sec 2 It shall be unlawful for any person to discharge fire Crackers within the Public streets, alleys, or grounds of said Village - Every person so offending shall forfeit upon Conviction thereof, and pay a fine of not more than Five dollars, nor less than one dollar, or be imprisoned in the Jail for not more than ten hours, nor less than one hour, both at the discretion of the Court -

Sec 3 This Ordinance shall be in force from and after its passage and publication -

An Ordinance Granting the P. Ft. W. & C. R. R. Co. to lay water pipes in streets.

 Sec 1 Be it Ordained by the Town Council of the Village of Alliance, That the privilege granted to the Pittsburgh Fort Wayne & Chicago R. R. Co. to lay down pipes, along certain streets or alleys, as best suits their convenience for the conveyance of water from their Reservoirs to their shops & other buildings at or near the depot

Sec 2 Said pipes to be laid at such a depth and in such a Manner, as not to interfere with the proper drainage or use of said streets, and to leave the same in as good repair as they were in before breaking them -

Sec 3 This Ordinance to take effect and be in force from and after its passage & publication.

to prevent Gambling, ^{the} Destruction
of Ornamental Trees, fruit or shade trees, Picket
fences & Vegetables &c

Be it Ordained, by the Town Council of the
Incorporated Village of Alliance, that it shall
be unlawful for any person or persons to
play at any game of Chance, whatsoever,
for any sum of Money or other property of
Value, or shall make any bet or wager for
any sum of Money, or other property of Value
on any game of Chance, or shall knowingly
suffer and allow any gambling to be done
or carried on in and upon or about their
premises.

each and every person or persons so offen-
ding shall upon Conviction thereof be fined
in any sum not less than Five dollars, nor
exceeding One hundred dollars, and be im-
prisoned untill the same is paid, and in
addition at the discretion of the Court, may
be imprisoned not to exceed twenty days.

That if any person or persons, shall cut
break, hack or in any other Manner injure
or destroy, any fruit Ornamental or shade
tree, in and upon or about any lot, in said
Village; every person so offending, upon Con-
viction thereof, shall be fined in any sum
not more than Fifty dollars, nor less than
three dollars for every tree so injured or des-
troyed, and be imprisoned untill the fine
and costs are paid.

That if any person or persons shall wilfully
break, injure or destroy any Picket fence or
any other kind of fence, around any lot or
lots in said Village, or shall break injure or
destroy any article either useful or ornamen-
tals in and upon any lot or lots in said
Village. every person so offending shall upon
Conviction thereof, shall be fined in any sum
not less than three dollars, nor more than Fifty
dollars, with Costs of prosecution and be im-
prisoned untill the same are paid.
