

Council Chamber Alliance Ohio
July 23rd 1894

Council met in regular session with President Bush in the chair and the following members present Harris Kay Melaney Conger Trail Williams absent. Buck Lambaugh Davidson Sargent ~~Thilerson~~. On motion of Conger the reading of the minutes of the preceding meeting was dispensed with.

Relative to the purchase of the Graham Property

Harris moved that the motion to adopt the report of the permanent improvement committee relative to the purchase of the Graham property which was tabled at the preceding meeting be taken from the table seconded by Trail and carried. Harris moved to amend the original motion by providing that before the purchase of the property the solicitor ascertain whether the title to the same is perfect, seconded by Conger and carried. The yeas and nays were then called on the motion as amended, resulting Yeas Conger Harris Kay Melaney Trail Williams Bush Yeas 7 nays none and the motion was declared carried.

Appropriate \$50⁰⁰ to pay expenses of Suit

Trail moved that there be appropriated the sum of \$50⁰⁰ to pay the expenses of the appropriation case in the matter of the Kayler property soon to be heard in the Probate Court, seconded by Conger and carried Yeas 7 nays 0.

Committee to secure testimony in Kayler case

Melaney moved that there be a committee appointed by the chair to assist the solicitor in procuring testimony in the Kayler appropriation case, seconded by Conger and carried and the chair appointed as said committee Melaney, Trail and Harris.

\$50⁰⁰ to be placed in Clerk's hands to defray expenses

Harris moved that the \$50⁰⁰ appropriated be placed in the hands of the clerk to be used in defraying the expenses as set forth in the motion to appropriate the same, seconded by Williams and carried.

Harris offered the following resolution and moved its adoption. "Be it resolved by the Council of the City of Alliance Ohio that the city of Alliance offer to confess judgment in the sum of \$5166²/₃ and costs in the appropriation proceeding now pending in the Probate Court of Stark County Ohio in favor of Raymond S. Kayler in payment for his property and the City Solicitor is hereby instructed to offer to confess said judgment for the City."

Key seconded the motion to adopt. The yeas and nays were called resulting yeas Conger Harris Key McLaney Trail Williams Bush. Yeas 7 nays none The resolution was declared adopted and on motion of Conger Council adjourned
