AN ORDINANCE ESTABLISHING RATES FOR RESIDENTIAL GARBAGE COLLECTION FOR JULY 1, 2018 THROUGH JUNE 30, 2019, AND DECLARING AN EMERGENCY.

WHEREAS, Alliance Codified Ordinance 937 was created to enable the City of Alliance to regulate Garbage and Rubbish Collection in the City of Alliance; and

WHEREAS, the Alliance City Council adopted Ordinance 33-17 which amended Alliance Codified Ordinance 937; and

WHEREAS, Ordinance 33-17 changed the provisions of A.C. O. 937 to allow the City Council to set yearly Garbage Rates; and

WHEREAS, the rates the City is charged for residential garbage collection are set to be increased beginning July 1, 2018; and

WHEREAS, the City of Alliance needs to consider a similar increase in the Garbage Rates charged for residential garbage collection.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLIANCE, STARK AND MAHONING COUNTIES, OHIO AS FOLLOWS:

SECTION 1. Garbage rates for July 1, 2018 through June 30, 2019 are set as shown in Exhibit A attached to this ordinance.

SECTION 2. That this Ordinance is hereby DECLARED to be an EMERGENCY MEASURE, necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Alliance and for the further reason that the current garbage fees change on June 30, 2018; and provided it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 3. That it is FOUND and DETERMINED that all formal actions of this Council concerning and relating to the adoption of this Ordinance were resolved in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.



Standard Service	\$	14.52	1.3%
Backdoor Service	\$	25.11	1.6%
Bag Service (Seniors)	\$	7.24 \$ 0.36 per bag	2.6%
Additional Carts (monthly)	\$	3.00	NC
Cart Replacement (per time)	\$	99.00	NC
Cart Delivery (per time)	\$	15.00	NC

Minipacker collection on private streets adds \$3.00 per month to the service rate selected.

Garbage service rate is per month, due in the month of service.

The service rate may be adjusted by 50% for months where service is starting after the 15th day of the month or ending on or before the 15th day of the month.
