The roll being called, the following members answered to their names: Messrs. Cary, Hall, Lower, H. T. Miller, and Weaver. Present 5, absent 2.

On motion of Weaver, seconded by Lower, the reading of the minutes was dispensed with.

Penalty of 10% on Assessment on Park Avenue moved to be re-mitted

The City Solicitor called Council's attention to the assessment of John Joyce on Park Avenue which he stated the assessment was unpaid on account of life interest being held by Mrs. Blanche Moore and that there had accumulated a penalty of ten (10%) per cent, that Mrs. Moore was desirous of paying the assessment but objected to the penalty. Weaver moved seconded by Lower that the penalty of ten (10%) per cent be remitted on the above assessment and the Clerk was instructed to certify the above action of council to the County officials, which motion was agreed to.

Andrews desires definite decisions of Council

The City Solicitor stated that Mr. Andrews who represented the Fording estate desired the definite decisions of Council as to whether they were going to purchase the Fording property on Union Avenue. On motion of Hall seconded by Weaver, the proposition was laid on the table.

Ordinance No. 121-D

An ordinance providing for the issuance of bonds of the City of Alliance, Ohio, in the sum of \$24,200.00 in anticipation of the collection of special assessments for the purpose of paying the cost and expense of improving West State Street from Rockhill Avenue to the West Corporation Line by grading, draining, curbing and paving with brick block, bituminous macadam, or reinforced concrete was read the second time.

Ordinance No. 122-D

An ordinance providing for the issuance of bonds of the City of Alliance, Ohio, in the sum of \$2,225.00 in anticipation of the collection of special assessments for the purpose of paying the cost and expense of improving South Union Avenue from Main Street to State Street by surface treatment with Tarvia asphalt or their equal was read the second time.

An ordinance providing rules and regulations for the erection and maintenance of signs and other advertising medium over a street or public place in the City of Alliance, Ohio was read the first time and referred to the Judiciary committee.

Resolution No. 124-D

Introduction of Res. 124-D

To issue a certificate of indebtedness of the City of Alliance, Ohio to provide funds to meet the appropriations by Council for the Hospital and General funds was read the first time and referred to the Finance Committee.
